QUEENSBURY THEATRE ELECTED BOARD:

This board is the governing body of Queensbury Theatre and its education wing, the Tribble School for the Performing Arts. Directors must apply and be elected by the existing board and, once elected, be able to serve a 3 year term as a voting member of the full elected board - terms running from June 1st through May 31st of each year. All full elected board directors are expected to attend monthly board meetings, and to serve on at least one sub-committee. Full Board Directors commit to supporting the ongoing mission of QT and TSPA programming with a combination of time and resources.

A minimum \$1,500 Annual Qualifying Contribution is required.

QUEENSBURY ADVISORY BOARD

This board is an ancillary group of community members who wish to support the programming of Queensbury Theatre and the Tribble School without the larger responsibility or time commitment of the full elected board. Advisory Board members are asked to attend only one board meeting with the full elected directors - beyond this, the commitment is one of a more social and networking nature. Advisory members should be community members with a love of the arts, and an interest in staying connected to, and supporting the ongoing programming of Queensbury Theatre and the Tribble School - through participation in quarterly social gatherings, promotion of QT and TSPA programming, and through networking with other likeminded community members!
